RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of May 4, 2017, by SILICON VALLEY BANK, a California corporation ("Bank") in favor of InsideTrack, Inc., a Delaware corporation ("Company") with its principal place of business located at 1620 Montgomery Street, Suite 230, San Francisco, CA 94111.

Recitals

WHEREAS, Bank and Company entered into that certain Amended and Restated Loan and Security Agreement dated as of the March 10, 2010, as defined therein (the "Loan Agreement").

WHEREAS, in connection with the Loan Agreement, Company granted a security interest to Bank in the Intellectual Property Collateral, including without limitation, the trademarks listed on Exhibit A attached hereto, under an Intellectual Property Security Agreement dated as of April 22, 2014 (the "IP Security Agreement"), and recorded with the US Patent and Trademark Office on January 11, 2016 at Reel Number 5706 and Frame Number 0689.

WHEREAS, all outstanding obligations of the Company under or relating to the Loan Agreement, the IP Security Agreement, and the other documents related thereto, have been paid and satisfied in full and irrevocably discharged, terminated and released and all security interests and other liens granted to or held by Bank in all of the assets and property of the Company shall be forever and irrevocably satisfied, released and discharged.

ACCORDINGLY, Bank agrees to release its security interest in the Intellectual Property Collateral.

Agreement

Now therefore, Bank agrees to terminate and release its security interest in the Intellectual Property Collateral and reassigns to Company, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral.
