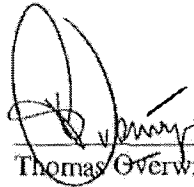
1. **Article I** of the Amended and Restated Certificate of Incorporation is hereby amended by deleting the existing Article I and substituting the following in its place:
