## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on March 20, 2017, by COMERICA INCORPORATED, successor by merger to IMPERIAL BANK, (the "Bank"), to the Grantor listed on Schedule A (the "Grantor").

WHEREAS, the Grantor and Imperial Bank are party to a Trademark Security Agreement dated as of August 5, 1994 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Bank, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on October 5, 1994 at reel/frame 1227/0258;

WHEREAS, Bank and Imperial Bank entered into a merger, dated September 25, 2001 and recorded in the United States Patent & Trademark Office on February 6, 2002 at reel/frame 2448/0456;

WHEREAS, the Bank wishes to release its security interest in the Trademarks and retransfer and reassign to the Grantor without recourse all of the Bank's right, title and interest in and to those Trademarks.



IN WITNESS WHEREOF, the Bank has caused this Release to be executed by its duly authorized officer.


