NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned, sold, quit-claimed, released, set over, conveyed and transferred and by these presents does hereby assign, sell, quit-claim, release, set over, convey and transfer absolutely unto Assignee, *nunc pro tunc*, as of the date of the aforementioned transaction, all right, title and interest, together with that part of the goodwill of the business connected with the use of and symbolized by the Trademark Property, whatsoever Assignor now has or may have in and to the Trademark Property, including the right to sue and recover for past, present and future infringement of the Trademark Property and the right to sue and collect damages for such infringement, the same to be held and enjoyed by Assignee, its assigns and successors, to the full end of the term or terms for which the Trademark Property is granted or may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor, had this assignment and sale not been made.
