RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of November 11, 2016 (the "Effective Date"), by Rosenthal & Rosenthal, Inc., 1370 Broadway, New York, NY 10018 (the "Grantee").

WHEREAS, Weeplay Kids LLC located at 25 West 39th Street, 5th Floor, New York, NY 10018 (the "Grantor") entered into (i) that certain Factoring Agreement, dated February 7, 2011 (the "Factoring Agreement"), by and between Grantor and Grantee, and (ii) that certain Security Agreement, dated February 7, 2011 (the "Trademark Security Agreement"), with the Grantee in order to convey to Grantee a security interest in the trademarks set forth on Schedule A annexed hereto, therefor (the "Weeplay Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on Reel 004480, Frame 0083; and

WHEREAS, the Grantee agrees to formally release and re-convey to the Grantor the security interest in all of Grantor's right, title and interest in and to the Weeplay Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Grantee hereby releases and re-conveys, without representation or warranty, to the Grantor all of the Grantor's security interest and rights that were granted to the Grantee pursuant to the Trademark Security Agreement and the Factoring Agreement, respectively, in and to the Weeplay Collateral.

2. The Grantee acknowledges and affirms that all of the rights, interests, and remedies of the Grantee concerning the Weeplay Collateral pursuant to the Trademark Security Agreement and the Factoring Agreement are hereby terminated.

3. This Release shall not constitute a release of Grantee's security interest in any other trademark and/or collateral under the Factoring Agreement or Trademark Security Agreement, and the Factoring Agreement and Trademark Security Agreement shall each otherwise continue in full force and effect, including with respect to any such other trademarks and/or collateral.


