**Whereas**, TOGI hereby agrees to grant an exclusive license with the right to sublicense in and to the Intellectual Property to BRANDS and will execute such an agreement concurrently herewith;

**Now therefore**, for and in consideration of TOGI's agreement to grant to BRANDS an exclusive license with the right to sublicense, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BRANDS hereby assigns, transfers, conveys and sets over to TOGI, the entire right, title and interest in and to the Intellectual Property, including without limitation the entire right, title and interest in and to the trademark and copyright registrations and applications for registration listed at Schedule A, and along with any and all goodwill symbolized thereby, the same to be held and enjoyed by TOGI, its successors, assigns
