**TERMINATION AND RELEASE
OF
PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT dated as of May 5, 2017, by FIFTH THIRD BANK, an Ohio banking corporation (the "Secured Party").

WHEREAS, CAR-BER INVESTMENTS INC., an Ontario corporation, successor in interest by amalgamation to CAR-BER Testing Services, Inc., an Ontario corporation (the "Grantor") and the Secured Party entered into a Patent and Trademark Security Agreement, dated as of December 20, 2010 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on April 13, 2011, at Reel 004521, Frame 0336 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Loan Agreement (as defined in the Security Agreement);

WHEREAS, pursuant to the Loan Agreement and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Trademarks (as defined in the Security Agreement), including, without limitation, the marks listed on Exhibit A hereto. The Trademarks are referred to herein collectively as the "Intellectual Property"; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.

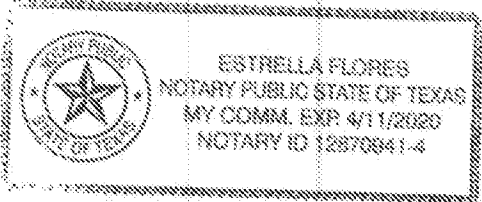


