**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release"), dated as of November 2, 2016, is made by WESTERN ALLIANCE BANK, as successor in interest to Bridge Bank, National Association (the "Collateral Agent"), pursuant to the Loan and Security Agreement, dated as of June 29, 2016 (as amended from time to time, the "Loan Agreement").

WITNESSETH

WHEREAS, OPENMAIL LLC (the "Grantor") is a party to the Loan Agreement;

WHEREAS, pursuant to the Loan Agreement, the Grantor executed and delivered to the Collateral Agent that certain Intellectual Property Security Agreement, dated as of June 29, 2016 (the "Intellectual Property Security Agreement") and recorded with the United States Patent and Trademark Office on August 10, 2015 at Reel/Frame No. 5596/0451, pursuant to which the Grantor granted to the Collateral Agent a security interest in all of its right, title and interest in the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement);


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Intellectual Property Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Collateral Agent release its security interest in all of its right, title and interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Intellectual Property Collateral, including the trademark registration set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Intellectual Property Collateral under the Intellectual Property Security Agreement and the Loan Agreement.
