**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("*Termination and Release*"), dated as of May 1, 2017, is from BANK OF AMERICA, N.A., a national banking association ("*Secured Party*"), to IDC ENCHANTED LIGHTING COMPANY, LLC, a Delaware limited liability company ("*Company*").

WHEREAS, pursuant to the Amended and Restated Pledge, Assignment and Security Agreement dated as of December 30, 2015 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "*Security Agreement*") in favor of Secured Party, a security interest was granted by the Company to Secured Party in the Company's Intellectual Property (defined in the Security Agreement) listed on Exhibit A and Exhibit B attached hereto (the "*Released Intellectual Property*");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office, at Reel/Frame Number 037485/0235, each on January 12, 2016; and

WHEREAS, Secured Party now desires to terminate and release its security interest in the Released Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, each of Secured Party and the Company hereby state as follows:

1. Definitions. Capitalized terms used but not specifically defined herein shall have the meanings given to them in the Security Agreement.

2. Termination and Release of Security Interest. Secured Party hereby terminates, releases, and discharges its Security Interest in the Released Intellectual Property listed on Exhibit A and Exhibit B attached hereto. Any and all right, title, or interest of Secured Party in such Released Intellectual Property and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Released Intellectual Property and any and all causes of action which may exist by reason of infringement of the Released Intellectual Property, shall hereby cease and become void.



Secured Party hereby agrees to duly execute, acknowledge, procure, and deliver, all at the expense of the Company, any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest in the Released Intellectual Property contemplated hereby.

4. Counterparts. This Termination and Release may be executed in any number of counterparts which shall together constitute one and the same document.
