## TERMINATION OF SECURITY AGREEMENT

This TERMINATION OF SECURITY AGREEMENT (the "Termination") is made and entered into on this 5<sup>th</sup> day of May, 2017, by Wells Fargo Credit, Inc., a Minnesota corporation (the "Secured Party"), in favor of Global Industries, Inc., a Nebraska corporation (the "Debtor").
