CORRECTIVE ASSIGNMENT

This Corrective Assignment (“Corrective Assignment”) is made and entered into by and between American Covers, LLC, a Utah limited liability company with a principal address of 533 Maryville University Drive, St Louis, Missouri 63141, United States of America (“Assignor” or “American Covers”), on the one hand, and Energizer Brands II LLC, a Delaware limited liability company with a principal address of 533 Maryville University Drive, St Louis, Missouri 63141, United States of America (“Assignee” or “EBII”), on the other hand, and is effective *nunc pro tunc* as of July 18, 2016 (the “Effective Date”). Each of the above-referenced organizations may be referred to as a “Party”; collectively, they may be referred to as the “Parties.”

WHEREAS, on March 29, 2017, American Covers and EBII executed a Trademark Assignment (the “Assignment”) of all right, title, and interest in and to certain Marks (as set forth in Schedule A of the Assignment) from American Covers to EBII;

WHEREAS, Schedule A of the Assignment inadvertently included registrations of marks incorporating the HANDSTANDS mark (the “HANDSTANDS Marks”);

WHEREAS, the Parties agree that the HANDSTANDS Marks were not transferred to EBII and should not have been included in Schedule A, and American Covers retains all right, title, and interest in and to the HANDSTANDS Marks;

WHEREAS, on March 30, 2017, the Assignment was recorded with the United States Patent and Trademark Office (the “USPTO”), changing the records associated with United States Registration Nos. 4606408, 4874595, 4606409, 2731768, 4859927, 4735488, and 2731770 of HANDSTANDS Marks (the “United States HANDSTANDS Marks”) and others to reflect EBII as the owner;

WHEREAS, the Parties desire to correct this error by updating the USPTO records associated with the United States HANDSTANDS Marks to reflect that American Covers remains the rightful owner of each such registration.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:


1. The HANDSTANDS Marks underlying United States Registration Nos. 4606408, 4874595, 4606409, 2731768, 4859927, 4735488, and 2731770 are owned by American Covers and were inadvertently included in the assignment recorded with the USPTO at Reel/Frame 6022/0819 on March 30, 2017.

2. The Parties direct the USPTO to record this Corrective Assignment against United States Registration Nos. 4606408, 4874595, 4606409, 2731768, 4859927, 4735488, and 2731770 to reflect that American Covers is the rightful owner, and that EBII never obtained any right, title, or interest in or to the United States HANDSTANDS Marks.
