TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “**Termination and Release**”) is granted as of May 9, 2017 by **SILICON VALLEY BANK**, as Administrative Agent (the “**Assignee**”), in favor of **NPSA, INC.**, a Delaware corporation (“**NPSA**”), **AVECTRA, INC.**, a Delaware corporation (“**Avectra**”), **NFI STUDIOS, INC.**, a Florida corporation (“**NFI**”), and **PEACH NEW MEDIA, INC.**, a Delaware corporation (“**Peach New**”, and together with **NPSA**, **Avectra**, and **BFI**, each individually, a “**Grantor**”, and collectively, the “**Grantors**”).

WHEREAS, **NPSA** executed and delivered a Trademark Security Agreement dated as of March 20, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**NPSA Agreement**”) granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the Assignment Division of the United States Patent and Trademark Office (“**USPTO**”) on March 20, 2013, at Reel 4994, Frame 0687;

WHEREAS, **Avectra** and **NFI** executed and delivered a Trademark Security Agreement dated as of August 19, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Avectra/NFI Agreement**”) granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on August 19, 2013, at Reel 5093, Frame 0851;

WHEREAS, **Peach New** executed and delivered a Trademark Security Agreement dated as of February 13, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Peach New Agreement**” and, together with the **NPSA Agreement** and **Avectra/NFI Agreement**, collectively, the “**Grants**”), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on February 17, 2015, at Reel 5460, Frame 0905;

WHEREAS, **Grantors** have requested that **Assignee** hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of **Grantors** in, to and under all of the trademarks and trademark applications described in the **Grants** (collectively, the “**Trademarks**”) as herein provided; and

WHEREAS, **Grantors** have requested that the **Assignee** provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the **Trademarks** as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the **Assignee** hereby:

1. terminates the **Grants** and releases, terminates and discharges all liens and security interests in the **Grantors’** right, title and interest in, to and under the **Trademarks**, and all goodwill associated therewith, including those **Trademarks** identified in Schedule I hereto;

2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any Grantors', or any Grantors' respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
