**AMENDMENT AND REAFFIRMATION OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Amendment and Reaffirmation of Intellectual Property Security Agreement (this "Agreement") is made and entered into as of May 9, 2017, by Vitamin Shoppe Procurement Services, Inc., a Delaware corporation (the "Grantor"), in favor of JPMorgan Chase Bank, N.A, a national banking association, in its capacity as Administrative Agent under the IP Security Agreement (as defined below) (in such capacity, together with any successors and assigns, the "Administrative Agent") for the benefit of itself, the Lenders and the other Secured Parties under that certain Credit Agreement (as defined below).

RECITALS:

WHEREAS, the Grantor, certain Affiliates of the Grantor, the Administrative Agent, and the financial institutions from time to time party thereto are parties to that certain Amended and Restated Loan and Security Agreement dated as of January 20, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, the Grantor entered into that certain Intellectual Property Security Agreement dated as of March 20, 2015 (as amended, restated and supplemented from time to time, the "IP Security Agreement") in connection with the Credit Agreement.

WHEREAS, pursuant to the Credit Agreement and the IP Security Agreement, as collateral security for all of the Obligations, the Grantor has pledged and assigned to the Administrative Agent, and granted to the Administrative Agent, for the benefit of itself, the Lenders and the other Secured Parties a continuing security interest in all of its trademarks, patents, the applications and registrations thereof, and all proceeds thereof (collectively, the "Collateral").

WHEREAS, the Grantor desires to amend certain provisions of the IP Security Agreement and reaffirm its obligations under the IP Security Agreement on the terms and conditions herewith in connection with the Credit Agreement and the IP Security Agreement. Unless otherwise noted, capitalized terms used but not defined herein have the meanings assigned to them in the IP Security Agreement as amended hereby or, as applicable, in the Credit Agreement.

Accordingly, in consideration of the mutual agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Recitals. Each and all of the foregoing recitals are true and correct and are incorporated herein by reference.

SECTION 2. Amendment to the IP Security Agreement. By executing and delivering this Agreement, the Grantor hereby grants to the Administrative Agent, a security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademarks described on Annex A attached hereto (the "Specified Trademarks"), subject to the terms and

conditions of the Credit Agreement, and the Specified Trademarks shall be deemed to be listed on Schedule A of the IP Security Agreement.

SECTION 3. Reaffirmations. The terms and provisions set forth in this Agreement shall modify and supersede all inconsistent terms and provisions set forth in the IP Security Agreement, and the terms and provisions (unless amended pursuant to this Agreement) of the IP Security Agreement are reaffirmed and confirmed and shall continue in full force and effect. The Grantor hereby reaffirms and confirms its obligations to the Administrative Agent, for the benefit of itself, the Lenders and the other Secured Parties under the IP Security Agreement and acknowledges that the security interest in the Collateral granted thereunder shall secure all the Obligations, as amended, increased and/or extended pursuant to the Credit Agreement. As reaffirmed hereby, the IP Security Agreement shall continue to be legal, valid, binding and enforceable in accordance with their respective terms.

SECTION 4. No Waiver. Nothing contained in this Agreement shall be construed as a waiver by the Administrative Agent of any covenant or provision of the IP Security Agreement, the other Financing Agreements, or of any other contract or instrument between the Grantor and the Administrative Agent, and the failure of the Administrative Agent at any time or times hereafter to require strict performance by the Grantor of any provision thereof shall not waive, affect or diminish any right of the Administrative Agent to thereafter demand strict compliance therewith. The Administrative Agent hereby reserves all rights granted under the IP Security Agreement, the other Financing Agreements, this Agreement and any other contract or instrument between and/ or among the Grantor and the Administrative Agent.

SECTION 5. Severability. Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining portions hereof or affecting the validity or enforceability of such provision in any other jurisdiction.

SECTION 6. APPLICABLE LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

SECTION 7. Successors and Assigns. This Agreement is binding upon and shall inure to the benefit of the Grantor and the Administrative Agent and their respective successors and assigns, except the Grantor may not assign or transfer any of its rights or obligations hereunder without the prior written consent of the Administrative Agent, other than as expressly permitted under the terms of the Credit Agreement.

SECTION 8. Counterparts. This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original but all of which when taken together shall constitute but one and the same instrument. Delivery of an executed signature page of this Agreement by facsimile transmission or other electronic transmission shall be effective as delivery of a manually executed counterpart hereof.

SECTION 9. Effect of Waiver. No consent or waiver, express or implied, by the Administrative Agent to or for any breach of or deviation from any covenant, condition or duty by the Grantor shall be deemed a consent or waiver to or of any other breach of the same or any other covenant, condition or duty.

SECTION 10. Headings. The headings of this Agreement are for purposes of reference only and shall not limit or otherwise affect the meaning hereof.

SECTION 11. Entire Agreement. THE IP SECURITY AGREEMENT, THIS AGREEMENT AND ALL OTHER INSTRUMENTS, DOCUMENTS AND AGREEMENTS EXECUTED AND DELIVERED IN CONNECTION WITH THIS AGREEMENT REPRESENT THE FINAL AGREEMENT AMONG THE PARTIES AND MAY NOT BE CONTRADICTED BY EVIDENCE OF PRIOR, CONTEMPORANEOUS OR SUBSEQUENT ORAL AGREEMENTS OF THE PARTIES. THERE ARE NO ORAL AGREEMENTS AMONG THE PARTIES.



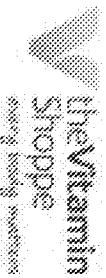

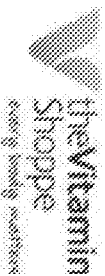
