**ARTICLES OF CONVERSION
OF
UNITEC INC.
INTO
UNITEC, LLC**

These articles of conversion (these "Articles") are dated as of September 19, 2016 (the "Execution Date"), and are made by **UNITEC INC.**, a Maryland corporation (the "Converting Corporation"). The Converting Corporation certifies to the Maryland State Department of Assessments and Taxation (the "SDAT") as follows:

1. The name of the Converting Corporation is Unitec Inc.
2. The Converting Corporation was formed under the laws of the State of Maryland on June 13, 1985, when its original articles of incorporation were filed with the SDAT.
3. The Converting Corporation will convert into a Maryland limited liability company named Unitec, LLC (the "LLC").
4. The conversion of the Converting Corporation into the LLC has been approved in accordance with the provisions of Subtitle 9 of the Maryland General Corporation Law and the provisions of Subtitle 11 of the Maryland Limited Liability Company Act.
5. The manner and basis of converting the outstanding shares of stock of the Converting Corporation into membership interests of the LLC are as follows:
 - (a) Each and every of the 20,000 shares of common stock in the Converting Corporation that is outstanding at the point in time immediately before the conversion will automatically be converted into a .005% membership interest in the LLC immediately upon the SDAT's acceptance for record of these Articles, and such membership interests will, in the aggregate, constitute a 100% membership interest in the LLC; and
 - (b) At the point in time immediately after such conversion, such membership interests will constitute all of the membership interests in the LLC.
6. These Articles are to be effective immediately upon their acceptance for record by the SDAT.

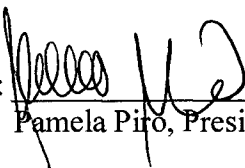
