TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of April 12, 2016 by MADISON CAPITAL FUNDING LLC, as Agent (“Agent”).

WITNESSETH:

WHEREAS, Agent and MADISON STREET PROVIDER NETWORK, LLC, a Colorado limited liability company (“Grantor”), were parties to that certain Trademark Security Agreement dated as of September 30, 2015 (the “Assignment”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “Trademarks”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule A hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on September 30, 2015, at Reel 5634, Frame 0294; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

(a) each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(b) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent’s right, title and interest in and to the Trademarks.
