**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of May 10, 2017 (this “**Release**”), is made by AB Value Partners, L.P., as Lender (the “**Lender**”).

This Release of Security Interest in Trademarks shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
