## ASSIGNMENT OF TRADEMARK

NOW, THEREFORE, in consideration of One Dollar and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor, by these presents, has sold, have sold, assigned and transferred, and does hereby sell, assign and transfer unto Assignee the full and exclusive right, title and interest, together with the goodwill symbolized by the Mark, both legal and equitable, for all countries including the United States, its Territories, and Possessions, the same to be held and enjoyed by

Assignee for its own sole use and behoof, and for the use and behoof of its successors, assigns, or other legal representatives, to the full extent as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made; together with all claims for damages, with the right to sue for, and collect the same.

FURTHER, Assignor hereby represents, warrants and covenants that no assignment, license, transfer, conveyance or agreement for any of the foregoing have been made affecting, including or involving any rights or ownership interest in the same; and


