BILL OF SALE

In accordance with the provisions of that certain Asset Purchase Agreement, dated as of September 8, 2016 (the "Agreement"), by and among (i) Travelsmith Outfitters Holdings, LLC, a Delaware limited liability company ("TS Buyer"); (ii) Chasing Fireflies Holdings, LLC, a Delaware limited liability company ("CF Buyer" and, together with TS Buyer, each a "Buyer" and collectively, the "Buyers"); (iii) TTA Operations, Inc., a Delaware corporation ("TTA"); (iv) Chasing Fireflies, LLC, a Delaware limited liability company and wholly owned subsidiary of TTA ("CFF"); (v) The Cornerstone Brands Group, Inc., a Delaware corporation ("CBG"); and (vi) TravelSmith Outfitters, Inc., a California corporation and wholly owned subsidiary of CBG ("TSO"). CFF and TSO are each referred to herein as a "Company" and collectively as the "Companies." Capitalized terms used but not otherwise defined herein shall have the respective meaning ascribed thereto in the Agreement.

The Companies have each represented and warranted, and do hereby represent and warrant, to Buyers that each Company is duly and validly authorized and empowered to make, execute, and deliver this Bill of Sale and to enter into the covenants, promises, and undertakings herein contained.

For the consideration recited in the Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, (i) CFF hereby sells, conveys, assigns, transfers, and delivers to CF Buyer free and clear of all Liens (other than Permitted Liens), all of CFF's right, title, and interest of every kind and character whatsoever in, to, or with respect to the CFF Assets, including without limitation, the intellectual property as set forth on Schedule A attached hereto; and (ii) TSO hereby sells, conveys, assigns, transfers, and delivers to TS Buyer free and clear of all Liens (other than Permitted Liens), all of TSO's right, title, and interest of every kind and character whatsoever in, to, or with respect to the TSO Assets, including without limitation, the intellectual property as set forth on Schedule B attached hereto.

The Companies covenant and agree that from time to time, whether on or after the date hereof, at their expense, they will execute and deliver such other documents and instruments and take such other actions as may reasonably be requested in writing by Buyers to distribute, transfer, and convey more effectively the Assets from the Companies to Buyers and their successors and assigns.

The identity and content of the Assets, and the representations and warranties of the Companies applicable to the Assets, together with all limitations, restrictions, disclaimers, and other provisions thereof, are contained in the Agreement.

THIS BILL OF SALE DOES NOT, NOR SHALL IT BE DEEMED TO, SUPERSEDE, SUPPLANT, EXTINGUISH, MODIFY, MERGE, OR EXPAND ANY OF THE REPRESENTATIONS AND WARRANTIES, COVENANTS, AGREEMENTS, CONDITIONS, INDEMNITIES, OR LIMITATIONS CONTAINED IN THE AGREEMENT.

This Bill of Sale shall be governed by the laws of the state of Delaware without regard to conflict of law principles. This Bill of Sale shall be binding upon the Companies and their legal representatives, successors, and permitted assigns and inure to the benefit of Buyers and their legal representatives, successors, and assigns.

Delivery of a signature page to this Bill of Sale by facsimile or other electronic means (e.g., email or PDF) shall be effective as delivery of a manually executed counterpart to this Bill of Sale.
