**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the "Release"), dated as of May 8, 2017, is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral trustee (the "Collateral Trustee") in favor of SUGARHOUSE HSP GAMING PROP. MEZZ, L.P., a Delaware limited partnership, SUGARHOUSE HSP GAMING, L.P., a Delaware limited partnership, and SUGARHOUSE HSP GAMING PROP. GP, L.L.C., a Delaware limited liability company (the "Grantors").

**W I T N E S S E T H**

WHEREAS, the Grantors and the Collateral Trustee entered into that certain Collateral Trust Agreement, dated as of May 24, 2013 (as amended, amended and restated, supplemented, renewed, extended or otherwise modified or replaced from time to time, the "Collateral Trust Agreement");

WHEREAS, pursuant to the Collateral Trust Agreement, the Grantors executed the First Lien Grant of Trademark Security Interest dated as of May 24, 2013 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on May 29, 2013 at Reel/Frame No. 5036/0763, pursuant to which the Grantors granted to the Collateral Trustee a security interest in all of their right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantors have requested that the Collateral Trustee release its security interest in all of its right, title and interest in and to the Trademark Collateral.

The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty of any kind or nature, any and all right, title and interest that the Collateral Trustee may have obtained in and to all of its Trademark Collateral under the Collateral Trust Agreement.
