**ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Section 48-209-104 of the Tennessee Limited Liability Company Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

Article 1 is hereby amended and restated in its entirety as follows:


“Article I.
