**NOTICE OF RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Notice of Release"), dated as of May 11, 2017, is made by MARQUETTE BUSINESS CREDIT, LLC, successor in interest to Marquette Business Credit, Inc., (the "Grantee") with an address of 5910 N. Central Expressway, Suite 1900, Dallas, Texas 75206.

WHEREAS, WASHINGTON AIR COMPRESSOR RENTAL CO., a District of Columbia corporation (the "Grantor") with an address of 12529 Parklawn Drive, Rockville, Maryland 20852 and the Grantee entered into that certain Loan and Security Agreement ("Security Agreement") dated as of June 20, 2013, whereby the Grantor granted to Grantee a continuing security interest in all of its right, title and interest in all trademarks, including, without limitation, each trademark listed on Schedule A attached hereto (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the records of the Trademark Division of the U.S. Patent and Trademark Office on June 27, 2013 at Reel 5058/Frame 0047; and

WHEREAS, the Grantee has agreed to release its security interest in, and discharge fully its lien on, the Trademarks in accordance with the terms of the Security Agreement, and as herein provided.

NOW, THEREFORE, pursuant to the Security Agreement, and upon the terms set forth in this Notice of Release, the Grantee hereby agrees as follows:

1. **Release of Security Interest.** For valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, discharges and releases any and all mortgages, liens and security interest granted to the Grantee in all of the Trademarks without representation, warranty or recourse of any kind, and any right, title or interest of the Grantee in such Trademarks shall hereby cease and become void; and

2. **Authorization.** The Grantee authorizes this Notice of Release to be recorded with the U.S. Patent and Trademark Office to evidence the termination and release granted therein.
