TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Min Zhou (the "Assignor"), whose address is 10-1107 Wanda Plaza, No. 3188 Renmin Road, Suzhou, China, is the applicant of the trademark "CAHAYA" which has been published in the Trademark Official Gazette on Apr 18, 2017, US Serial No. 87159274; WHEREAS, Shen Zhen Shi Zhi Cheng Zhi Yuan Wang Luo Ke Ji You Xian Gong Si (the "Assignee"), a corporation organized and existing under the laws of People's Republic of China, located at Bai Men Qian Gong Ye Qu Si Dong Liu Lou Xi, Long Gang Qu Nan Wan Jie Dao Bu Sha Lu 215 Hao, Shenzhen, Guangdong, 518114, CN, desires to acquire such Mark before its registration.

NOW THEREFORE, for good and valuable consideration, the Assignor and Assignee enter into a trademark assignment agreement and hereto agree as follows:

1. The Assignor does hereby assign to the Assignee all rights, title and interests derived from and in connection with the Mark in the Territory, together with the good will of the business symbolized by this Mark.
2. The Assignor represents and warrants that there are no liens or security interests against the Mark. To the Assignor's best knowledge, there are no parties who are using the Mark, own registrations or pending applications for registration of the Mark and there are no pending cases before the court or national authorities, which may adversely affect the Mark.
3. The Assignor shall furnish the Assignee with all necessary information on and in connection with the Mark, which may be required to perfect title in the Mark in the Assignee. The Parties hereto agree that this Agreement shall be submitted to the USPTO for transferring ownership.
4. The assignment fee is RMB 8,000. The Assignee must pay the fee within Three days via bank transfer after effective date of this agreement.
5. After the Effective Date, Assignor agrees to make no further use of the Mark or any mark confusingly similar thereto, anywhere in the world, except as may be expressly authorized by the owner(s) in writing, and Assignor agrees to not challenge Assignee's use or ownership, or validity of the Mark.

6. Any amendments, modifications, alternations or supplements to this Agreement shall be made in writing to be legally effective.
7. Any dispute, controversy or claim arising out of or relating to this Agreement, or breach, termination of invalidity hereof shall be settled through bona fide negotiations between the Parties.
8. This Agreement will be governed by and construed in accordance with the laws of People's Republic of China.
9. Each Party acknowledges that it has read this Agreement, understands it and agrees to be bound.
