**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARK, LICENSE AND COPYRIGHT SECURITY
AGREEMENT AND GRANT OF SECURITY INTEREST IN
TRADEMARK AND COPYRIGHT RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK, LICENSE AND COPYRIGHT SECURITY AGREEMENT AND GRANT OF SECURITY INTEREST IN TRADEMARK AND COPYRIGHT RIGHTS, dated as of May 8, 2017, is made by FIFTH THIRD BANK, an Ohio banking corporation ("Agent") in favor of ADDUS HEALTHCARE, INC. an Illinois corporation and CURA PARTNERS, LLC, a Tennessee limited liability company (each a "Grantor", and, collectively, the "Grantors").

WHEREAS, pursuant to the Loan and Security Agreement, dated as of November 2, 2009 and the Amended and Restated Security Agreement, dated as of August 11, 2014, Grantors granted a first priority security interest to the Agent in and to all Grantors' now owned or existing trademarks, including as set forth on Schedule I attached hereto (the "Trademarks"); and

WHEREAS, the Agent executed a Trademark, License and Copyright Security Agreement, dated as of November 2, 2009, ("2009 IP Security Agreement"), which was duly recorded on July 28, 2010 at Reel 4249, Frame 0298 with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office; and

WHEREAS, the Agent executed a Grant of Security Interest in Trademark and Copyright Rights, dated as of August 11, 2014, (together with the 2009 IP Security Agreement, collectively the "IP Security Agreements"), which was duly recorded on August 19, 2014, at Reel 5348 Frame 0192 with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office; and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to dissolve those liens and encumbrances created by the IP Security Agreements.

NOW, THEREFORE, for good and valuable consideration , the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreements in the Trademarks, (b) release its security interest in the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademarks.
