RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST, effective as of May 12, 2017, is made by Comerica Bank, as Administrative Agent, pursuant to the Security Agreement defined below (in such capacity, "Secured Party").

WHEREAS, Whale Shark Media, Inc., a Delaware corporation; CSB Acquisition Co., LLC, a Delaware limited liability company; Spectrawide Acquisition Co., LLC, a Delaware limited Liability Company; Spectrawide, Inc., a Texas corporation; CLTD Acquisition Co., LLC a Delaware limited liability company; SmallPonds, LLC, a Delaware limited liability company; Deals.Com, LLC, a Delaware limited liability company; and RMN Acquisition Co., LLC, a Delaware limited liability company, having a place of business at 515 South Congress, Suite 700, Austin, Texas 78704 executed and delivered that certain Intellectual Property Security Agreement dated as of November 28, 2010 (the "Security Agreement"), in favor of Secured Party;

WHEREAS, pursuant to the Security Agreement, Grantors granted and pledged to Secured Party a security interest in and to Grantor's right, title and interest in, to, and under the Collateral (as defined in the Security Agreement), including without limitation the Intellectual Property (as defined in the Security Agreement) as set forth on the attached Schedule A including without limitation all present and future rights (including, without limitation, the right to sue for past, present, or future infringements), titles, and interests of Grantors in and to all Intellectual Property applications, rights or licenses to use any trademarks, patents, copyrights, and all registrations and recordings thereof, including, without limitation, the Intellectual Property listed on Schedule A, and the goodwill of each business to which the Intellectual Property relates;


WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office in Trademark Reel/Frame 4422/0346; and

WHEREAS, the Secured Party no longer claims an interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Secured Party hereby releases to Grantor the security interest in, to and under the Collateral, including without limitation the Collateral identified on Schedule A.
