

WHEREAS, pursuant to (i) that certain Security Agreement dated as of November 12, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "2014 Security Agreement") among AMAG PHARMACEUTICALS, INC., a Delaware corporation ("AMAG"), LUMARA HEALTH INC., a Delaware corporation ("Lumara"), LUMARA HEALTH IP LTD., a Delaware corporation ("Lumara IP") and the Agent and (ii) that certain Security Agreement dated as of August 17, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "2015 Security Agreement"; together with the 2014 Security Agreement, each a "Security Agreement" and collectively, the "Security Agreements") among AMAG, Lumara, Lumara IP, CBR ACQUISITION HOLDINGS CORP., a Delaware corporation ("Acquisition") and CBR SYSTEMS, INC., a Delaware corporation ("Systems"; and together with AMAG, Lumara, Lumara IP and Acquisition, each a "Grantor" and collectively, the "Grantors") and the Agent, pursuant to which the Grantors executed and delivered to the Agent (i) that certain Grant of Security Interest in United States Patent and Trademarks and (ii) that certain Grant of Security Interest in United States Copyrights (each an "IP Security Agreement"; and collectively, the "IP Security Agreements"), for recordation with the United States Patent and Trademark Office (the "USPTO") and the United States Copyright Office (the "USCO"), as applicable;

WHEREAS, the IP Security Agreements were recorded with the USPTO on (i) November 12, 2014 with the trademark assignment division at Reel 5399, Frame 0983 for AMAG and at Reel 5400, Frame 0009 for Lumara IP and (ii) September 25, 2015 at Reel 5630, Frame 0335 for AMAG, at Reel 5630, Frame 0285 for Lumara IP and at Reel 5630, Frame 0314 for Systems;

WHEREAS the IP Security Agreements were recorded with the USPTO on (i) November 12, 2014 with the patent assignment division at Reel 034156, Frame 0214 for AMAG, at Reel 034156, Frame 0243 for Lumina IP, (ii) September 25, 2015 at Reel 036653, Frame 0065 for AMAG and at Reel 036653, Frame 0138 for Lumara IP and (iii) January 29, 2016 at Reel 037623, Frame 0181 for Systems;

WHEREAS the IP Security Agreements were recorded with the USCO on (i) November 14, 2014 at Document Number V9922D109 and (ii) October 28, 2015 at Document Number V9927D501 for Lumara; and

WHEREAS, pursuant to the terms and conditions of the Security Agreements and the IP Security Agreements, each Grantor assigned and pledged to the Agent, for the benefit of the Finance Parties, a security interest in all of each Grantor's right, title and interest in, to and under the following, whether then presently existing or thereafter arising or acquired (i) all United States trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, certification marks, collective marks, brand names, trademark rights arising out of domain names and trade dress which are or have been used in the United States, in any state, province or territory or possession thereof, or in any other place, nation or jurisdiction, package and other designs, and any other source or business identifiers, and general intangibles of like nature, and the rights in any of the

foregoing which arise under applicable Law, in each case whether registered or unregistered, and with respect to any and all of the foregoing: (a) the goodwill of the business symbolized thereby or associated therewith; (b) all registrations and applications in connection therewith, including registrations and applications in the USPTO or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, and including, without limitation, the registrations and applications referred to in Schedule A hereto; (c) all extensions and renewals thereof; (d) all claims for, and rights to sue for, past, present or future infringements, dilutions, and other violations thereof; (e) all Proceeds of the foregoing, including, without limitation, all income, license fees, royalties, damages and payments now or hereafter due or payable with respect to any of the foregoing, including damages and payments for past, present or future infringements, dilutions, or other violations thereof; and (f) all other rights corresponding thereto throughout the world, (ii) all United States patents and patent applications, including, without limitation the patents and patent applications referred to in Schedule B hereto, and, with respect to any and all of the foregoing: (a) all reissues, reexaminations, divisions, continuations, continuations-in-part, revisions, renewals or extensions thereof; (b) all claims for, and rights to sue for, past, present or future infringements and other violations thereof; (c) all Proceeds of the foregoing, including, without limitation, all income, license fees, royalties, damages and payments now or hereafter due or payable with respect to any of the foregoing, including damages and payments for past, present or future infringements or other violations thereof; and (d) all other rights corresponding thereto throughout the world and (iii) (a) all United States copyrights (including community designs), including but not limited to copyrights in software and databases, and all Mask Works (as defined under 17 U.S.C. § 901 of the U.S. Copyright Act), whether registered or unregistered; (b) all registrations and applications therefor including, without limitation, the registrations and applications referred to in Schedule C hereto, and all extensions and renewals thereof; (c) all claims for, and rights to sue for, past, present or future infringements and other violations thereof and (d) all Proceeds of the foregoing, including, without limitation, all income, license fees, royalties, damages and payments now or hereafter due or payable with respect to any of the foregoing, including damages and payments for past, present or future infringements or other violations thereof (collectively, the "IP Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, for the benefit of the Finance Parties, hereby agrees as follows:

The Agent hereby terminates the IP Security Agreements, and hereby terminates and releases the security interest in the IP Collateral arising under the Security Agreements and the IP Security Agreements.

If and to the extent the Agent has acquired any right, title or interest in, to or under any of the IP Collateral, it hereby irrevocably reassigns and retransfers all such right, title and interest to each Grantor.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.
