**ARTICLES OF AMENDMENT
TO THE CERTIFICATE OF FORMATION
OF WHITESELL INTERNATIONAL CORPORATION**

SECOND: The following amendments to the Certificate of Formation were unanimously adopted by the shareholders of the corporation on December 9, 2013, in the manner prescribed by the Alabama Business Corporation Act:

RESOLVED, that the corporation known as Whitesell International Corporation shall hereby amend its Certificate of Formation and change its name to Whitesell Formed Components, Inc.;

RESOLVED, FURTHER, that Article I of the Certificate of Formation of Whitesell International Corporation shall be deleted in its entirety and the following Article shall be substituted in lieu thereof:

WHITESELL FORMED COMPONENTS, INC.


THIRD: The Articles of Incorporation, as amended, are hereby ratified and confirmed.
