**ARTICLES OF AMENDMENT
TO THE CERTIFICATE OF FORMATION

RESOLVED, FURTHER, that Article I of the Certificate of Formation of Whitesell International Corporation shall be deleted in its entirety and the following Article shall be substituted in lieu thereof:

WHITESELL FORMED COMPONENTS, INC.


THIRD: The Articles of Incorporation, as amended, are hereby ratified and confirmed.
