**GRANT OF SECURITY INTEREST (TRADEMARKS)**

Dated: May 16, 2017

The undersigned, **THE YARD IP HOLDINGS LLC**, a New York limited liability company (the "Grantor"), is obligated to **ISRAEL DISCOUNT BANK OF NEW YORK** (the "Secured Party") under (i) the Corporate Guaranty Agreement, dated as of May 16, 2017 (as it may be amended, restated, supplemented or otherwise modified from time to time), by and among the Grantor, certain of its Affiliates from time to time party thereto (collectively with the Grantor, the "Guarantors"), and the Secured Party, and (ii) the Guarantor Security Agreement, dated as of May 16, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Guarantors and the Secured Party.

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor does hereby further grant to the Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.




