**TRADEMARK ASSIGNMENT AGREEMENT**

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (the "Agreement") is entered into as of May 10, 2017 by and between West Unified Communications Services Canada Inc., a Canadian corporation ("Assignor"), and West Interactive Services Corporation, a Delaware corporation ("Assignee").

**WHEREAS**, Assignor is the owner of the trademark listed on Exhibit A (the "Mark");

**WHEREAS**, Assignor wishes to assign the entire rights, title and interest in and to the Mark and the goodwill to Assignee and Assignee desires to assume such Mark and the goodwill and the respective parts of the business related thereto.

**NOW, THEREFORE**, for \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in and to the Mark together with that portion of the goodwill related to the Mark connected with the use of and symbolized by the Mark and the know how associated with and necessary to control the nature and quality of goods and services associated with the Mark, and all causes of action, past, present and future for infringement of the Mark.
2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Mark in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the Mark or the history thereof as may be known to it.
3. This Agreement shall be governed by and construed in accordance with the domestic laws of the State of Nebraska without reference to choice of law rules.
4. This Agreement may not be amended, modified or supplemented except by written agreement duly executed by both parties.
5. Assignor agrees not to challenge or assist or cooperate with any third party challenging or taking any position contrary to or inconsistent with Assignee's sole and exclusive right in and to the Mark or the validity of the Mark.
