WHEREAS, the Grantor and Collateral Agent entered into (a) that Trademark Security Agreement, dated as of January 21, 2011, and recorded in the United States Patent and Trademark Office on January 24, 2011 at Reel/Frame No. 04459/0059, (b) that Trademark Security Agreement, dated as of July 22, 2011, and recorded in the United States Patent and Trademark Office on July 25, 2011 at Reel/Frame No. 04590/0274 (c) that Trademark Security Agreement, dated as of December 14, 2012, and recorded in the United States Patent and Trademark Office on December 20, 2012 at Reel/Frame No. 04926/0033, (d) that Trademark Security Agreement, dated as of December 14, 2012, and recorded in the United States Patent and Trademark Office on December 20, 2012 at Reel/Frame No. 04926/0049, (e) that Trademark Security Agreement, dated as of December 14, 2012, and recorded in the United States Patent and Trademark Office on December 20, 2012 at Reel/Frame No. 04926/0077, (f) that Trademark Security Agreement, dated as of July 10, 2014, and recorded in the United States Patent and Trademark Office on July 17, 2014 at Reel/Frame No. 05324/0569, and (g) that Trademark Security Agreement, dated as of July 10, 2014, and recorded in the United States Patent and Trademark Office on July 17, 2014 at Reel/Frame No. 05324/0626; and

WHEREAS, Collateral Agent desires to release its security interest in and liens upon the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby states as follows:

1. Release. Collateral Agent, on behalf of itself and the other Secured Creditors (as defined in the trademark security agreements referenced above) hereby (i) terminates, releases, and discharges its lien on and security interest in the Released Trademarks, (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Trademarks and (iii) reassigns, grants, and conveys to the Grantor any and all right, title and interest it has in the Released Trademarks.

2. Recordation of Trademark Release. This Release has been executed and delivered by the Collateral Agent for the purpose of recording with the United States Patent and Trademark Office and the Canadian Intellectual Property Office.

3. Governing Law. This Release shall be construed in accordance with the laws of the State of Illinois without giving effect to any conflict of law principles (but giving effect to laws relating to national banks).
