## RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS (this “Release”), dated as of May 8, 2017, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION (“Wells Fargo”), in favor of ENFORA, INC., a Delaware corporation (“Grantor”). 
B. WHEREAS, Wells Fargo wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

Wells Fargo authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
