**CORRECTION BY DECLARATION**

I, Darren B. Cohen, declare as follows:


1. On June 26, 2007, the mark BANPRESTO and Design was registered to KABUSHIKI KAISHA BANPRESTO. under Registration No. 3,254,358 (hereinafter “the subject Registration”).
2. On September 25, 2008, the merger of KABUSHIKI KAISHA BANPRESTO and NAMCO BANDAI GAMES INC. was recorded under Reel/Frame Number 3859/0678 against all of the applications and registrations owned by the respective parties. Under that recordation, NAMCO BANDAI GAMES INC. became the owner of record of the subject Registration.
3. On May 29, 2014, the name change of NAMCO BANDAI GAMES INC. to BANDAI NAMCO GAMES INC. was recorded under Reel/Frame Number 5291/0139 against all of the applications and registrations owned by the respective parties.
4. On March 31, 2015, the assignment of the subject Registration from BANDAI NAMCO GAMES INC. to KABUSHIKI KAISHA BANPRESTO, trading as BANPRESTO CO., LTD., was recorded with the Assignments Branch under Reel/Frame Number 5488/0406.
5. On March 22, 2016, the name change of BANDAI NAMCO GAMES INC. to BANDAI NAMCO ENTERTAINMENT INC. was recorded under Reel/Frame Number 5755/0109 against all of the applications and registrations owned by the respective parties. This recordation inadvertently and erroneously included the subject Registration, which had since been assigned to KABUSHIKI KAISHA BANPRESTO, trading as BANPRESTO CO., LTD.

THEREFORE, as the inclusion of the subject Registration in the name change conveyance as recorded under Reel/Frame Number 5755/0109 was inadvertently done in error, it is respectfully requested that the chain of title be corrected to identify the current owner of the subject Registration as KABUSHIKI KAISHA BANPRESTO, trading as BANPRESTO CO., LTD.
