**RELEASE OF TRADEMARK COLLATERAL CONDITIONAL ASSIGNMENT AND
SECURITY AGREEMENT**

BE IT KNOWN THAT Warrantech Corporation, a corporation of the state of Nevada having an address of 2200 Highway 121, #100, Bedford, Texas 76021, the surviving corporation of the merger agreement dated June 6, 2006 between Warrantech Corporation and WT Acquisition Holdings, LLC and WT Acquisition Corp., its direct subsidiary, and Vemeco, Inc., a wholly owned indirect subsidiary of Warrantech Corporation, Vemeco, Inc. being a corporation of the state of Connecticut having an address of 2200 Highway 121, #100, Bedford, Texas 76021, had together entered into a "Trademark Collateral Conditional Assignment and Security Agreement" dated January 31, 2007 between Warrantech Corporation and Vemeco, Inc. (together the "Obligor") and AmTrust Financial Services, Inc. ("AmTrust"), a Delaware corporation having an office and place of business at 59 Maiden Lane, 43rd Floor, New York, New York 10038. By said Trademark Collateral Conditional Assignment and Security Agreement, Obligor granted to AmTrust in its capacity as the Collateral Agent a continuing security interest in and a general lien upon, and a conditional assignment of, all existing or thereafter acquired right, title, and interest in and to all of their trademarks, trade names, trade styles and service marks and all applications, registrations and recordings relating to the foregoing as may at any time be filed in the United States Patent and Trademark Office, or in any similar office or agency of the United States, or in any other country, including, without limitation, the trademarks, terms, designs and applications described in Schedules A and B attached hereto, together with all rights and privileges arising under applicable law with respect to Obligor's use of any trademarks, trade names, trade styles and service marks, and all reissues, extensions, continuations and renewals thereof (all of the foregoing being collectively referred to herein as the "Trademarks"); and all prints and labels on which such trademarks trade names, trade styles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature.

WHEREAS, the Trademark Collateral Conditional Assignment and Security Agreement was recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on February 13, 2007 at Reel/Frame 003480/000687 with respect to the trademarks identified in the attached Schedule A.

WHEREAS, the Trademark Collateral Conditional Assignment and Security Agreement was recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on February 13, 2007 at Reel/Frame 003480/000701 with respect to the trademark identified in the attached Schedule B.

WHEREAS, the parties wish to provide a document suitable for recording in the Trademark Assignment database of the PTO for purposes of recording the release and discharge of the security interest.

NOW, THEREFORE, BE IT KNOWN that AmTrust, for One Dollar and other good and valuable consideration, does hereby release and discharge the security interest in the Trademarks shown on Schedules A and B attached hereto and incorporated in this Release by reference, and any other trademarks, trade names, trade styles and/or services marks thereafter acquired. AmTrust confirms the termination of the Trademark Collateral Conditional Assignment and Security Agreement and hereby terminates the Trademark Collateral Conditional Assignment and Security Agreement and re-assigns to Obligor any right, title, and interest it may have in, to and under the Agreement.


