ASSIGNMENT OF TRADEMARKS AND GOODWILL

WHEREAS, Cobb Cinebistro, LLC, an Alabama limited liability company, 2000-B Southbridge Parkway, Suite 100, Birmingham, Alabama, 35209 ("Assignor") is the owner of the common law and statutory rights to the trademarks "CLUB CINÉ," "CINÉBISTRO" and design, "CLUB CINÉ," "SCORE EAT PLAY SOCIALIZE" and design, "MOVIES WITH TASTE," "CINÉBISTRO A COBB MOVIE THEATRE EXPERIENCE," and "CINEBISTRO," (hereinafter referred to as the "Trademarks") including the current federal registrations thereof (Registration Nos. 5049188, 4876956, 4027237, 4481824, 3887564, 3648390 (cancelled), and 3486063, respectively) (hereinafter referred to as the "Registrations");

WHEREAS, Cobb Theatres III, LLC, an Alabama limited liability company ("Assignee") has previously licensed the rights to use the Trademarks from Assignor and now is desirous of acquiring the entire interest of Assignor in and to the Trademarks and the goodwill of the business associated therewith;

NOW, THEREFORE, for ten dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, grant, assign, convey and transfer to Assignee all of Assignor's common law and statutory right, title and interest, in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the common law rights thereto, and the Registrations, and any modifications thereof, the same to be held and enjoyed by Assignee, for its own use and benefit and that of its successors, assigns and legal representatives, together with all claims for damages by reason of past infringement, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives.

Assignor represents and warrants to Assignee that it has full right, power and authority to make this assignment to Assignee in the manner set forth above, and that Assignor is transferring to Assignee all of Assignor's right and title to the Trademarks (and associated goodwill) and the

Registrations, free and clear of all liens, security interests, claims, interests, options, encumbrances, or indebtedness of any kind.

Assignor does hereby covenant and agree to execute and deliver such other and further instruments and take such other and further actions, at Assignee's expense, as may be necessary or appropriate to transfer to Assignee any and all interest in and to the Trademarks (and associated goodwill) and the Registrations.


