RELEASE OF SECURITY INTEREST

This Release Of Security Interest is made as of May 17, 2017, by CENTERFIELD CAPITAL PARTNERS III, L.P., a Delaware limited partnership ("Secured Party") in favor of BANNER SERVICE CORPORATION, an Illinois corporation ("BSC"), and BANNER MEDICAL INNOVATIONS, INC., an Indiana corporation (together with BSC, the "Grantor").

WHEREAS Grantor and Secured Party entered into that certain Subordinated Notes Purchase and Security Agreement, dated November 16, 2012 (the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, Grantor and Secured Party entered into that certain Trademark Security Agreement, dated December 6, 2016, recorded with the United States Patent and Trademark Office on December 14, 2016, at Reel 5948, Frame 0291 (the "Trademark Security Agreement"), under which Grantor granted to Secured Party a security interest in the Trademark Collateral (as that term is defined in the Trademark Security Agreement), including the trademarks set forth on Exhibit A attached hereto; and

WHEREAS, Secured Party agrees to release its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

- 1) Secured Party hereby terminates, cancels, discharges, and releases its security interest in all of the Trademark Collateral secured by the Loan Agreement or the Trademark Security Agreement;
- 2) Secured Party hereby terminates the Trademark Security Agreement; and
- 3) Secured Party acknowledges that this document may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other domestic or foreign governmental office to evidence the release granted herein.
