same, and that it has the full right to convey, free of licenses and encumbrances, all right, title
and interest in and to the Trademarks.
3. Right to Sue for Past Infringement. Assignor also assigns to Assignee all claims
for past damages by reason of past infringement or misappropriation of the Trademarks, with the
right to sue for and collect same for its own use and behalf and for the use and on behalf of
Assignee's successors, assigns or other legal representatives.
4. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be
executed, acknowledged and delivered, such further instruments and documents and to perform
such further acts as may be reasonably requested by Assignee to effectuate more fully the
transactions contemplated by this Assignment.

5. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.


