RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of May 19, 2017 to DOSKOCIL MANUFACTURING COMPANY, INC., a Texas corporation (the "Grantor"), by PNC BANK, NATIONAL ASSOCIATION, in its capacity as administrative agent (in such capacity, the "Agent"), with respect to each of the trademarks identified on Exhibit A to this Release (the "Released Trademarks").

WHEREAS, the Grantor and Agent entered into that Trademark Security Agreement, dated as of October 20, 2011 (the "Trademark Security Agreement"), and recorded in the United States Patent and Trademark Office on October 28, 2011 at Reel/Frame No. 004650/0616; and

WHEREAS, Agent desires to release its security interest in and liens upon the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby states as follows:

1. Release. Agent, on behalf of itself and the other Secured Creditors (as defined in the trademark security agreements referenced above) hereby (i) terminates, releases, and discharges its lien on and security interest in the Released Trademarks, (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Trademarks, (iii) reassigns, grants, and conveys to the Grantor any and all right, title and interest it has in the Released Trademarks, and (iv) terminates the Trademark Security Agreement.


2. Recordation of Trademark Release. This Release has been executed and delivered by the Agent for the purpose of recording with the United States Patent and Trademark Office.
