**ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT**

**THIS ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT** (the “Assignment”) is made and entered into as of May 19, 2017 by Deutsche Bank AG New York Branch, as the original administrative agent (in such capacity, “Assignor”), in favor of Cantor Fitzgerald Securities, as the successor administrative agent (in such capacity, “Assignee”).

**W I T N E S S E T H**

WHEREAS, Assignor is party to that certain Pledge and Security Agreement, dated as of April 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among, inter alios, SunEdison, Inc., the other grantors party thereto (together with SunEdison, Inc., collectively, the “Grantors”), and Assignor;

WHEREAS, pursuant to (i) the Security Agreement and (ii) all of the trademark security agreements made by the Grantors in favor of Assignor, including the trademark security agreements dated April 26, 2016 recorded at the United States Patent and Trademark Office at Reel 5778, Frame 0827, Reel 5778, Frame 0810, Reel 5778, Frame 0841, and Reel 5778, Frame 0864, and the trademark security agreement dated July 15, 2016 recorded at the United States Patent and Trademark Office at Reel 5840, Frame 0428 (collectively, the “Trademark Security Agreements”), the Grantors have granted to Assignor a continuing security interest in, and lien on, all of its right, title and interest in, to and under the trademark collateral as set forth under the Security Agreement and Trademark Security Agreements, including those trademark registrations and applications set forth on Schedule I (the “Trademark Collateral”);

WHEREAS, pursuant to that certain Amended and Restated Senior Secured Superpriority Debtor-in-Possession Credit Agreement, dated as of May 2, 2017, among, inter alios, SunEdison, Inc., a debtor and debtor-in-possession, as borrower, the lenders party thereto, and Assignee, Assignee has assumed and succeeded to all of the rights, powers, discretions, privileges and duties of Assignor as administrative agent thereunder; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the assignment by Assignor to Assignee of all of Assignor’s right, title and interest in, to and under the Security Agreement and the Trademark Security Agreements, including, without limitation, Assignor’s security interest in, and lien on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby covenant and agree as follows:

1. Terms. Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings specified in the Security Agreement.
2. Assignment. Assignor hereby transfers, assigns, grants and conveys to Assignee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Security

Agreement and the Trademark Security Agreements, including, without limitation, its security interest in, and lien on, the Trademark Collateral, and Assignee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and liens.

3. Acknowledgment of Grantors. The security interest assigned to Assignee as the new administrative agent for the Secured Parties pursuant to this Assignment, has been granted in conjunction with the security interest granted pursuant to the Security Agreement and Trademark Security Agreements, and the Grantors hereby (i) confirm their grant to Assignee of a security interest in, and lien on, the Trademark Collateral to secure the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations and (ii) acknowledge and affirm that the rights and remedies of Assignee with respect to its security interest in, and lien on, the Trademark Collateral are more fully set forth in the Security Agreement and the Trademark Security Agreements, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.

5. Counterparts. This Assignment may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.
