Without limiting the generality of the foregoing, Assignor and Assignee each hereby agree to execute or join with the other party in other actions reasonably requested by the other party in order to accomplish the aforesaid Assignment(s), including without limitation notifying and cooperating with the other party in confirming to any third parties the existence and effectiveness of the foregoing assignments.
