FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation. (If amendments are affected please set forth).

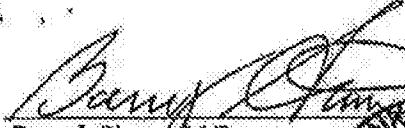

SIXTH: The merger is to become effective on March 14, 2014.
