This Certificate of Conversion (this "Certificate") has been duly executed and is being filed by the undersigned to convert Federal-Mogul Motorparts Corporation, a Delaware corporation (the "Corporation"), into Federal-Mogul Motorparts LLC, a Delaware limited liability company (the "LLC"), pursuant to the Delaware Limited Liability Company Act, as amended (the "DLLCA") and the Delaware General Corporation Law (the "DGCL"), and the undersigned hereby certifies as follows:

1. The Corporation was first incorporated in the State of Delaware pursuant to the DGCL on August 16, 2012.
2. Immediately prior the Effective Time (defined below), the jurisdiction of the Corporation is Delaware and the name of the Corporation is "Federal-Mogul Motorparts Corporation".
3. Immediately following the Effective Time, the jurisdiction of the LLC is Delaware and the name of the LLC (as set forth in the Certificate of Formation) is "Federal-Mogul Motorparts LLC".
4. The conversion of the Corporation into the LLC (the "Conversion") has been approved in accordance with the provisions of the DLLCA and the DGCL.
5. The Conversion shall be effective upon the filing of this Certificate of Conversion with the Secretary of State of Delaware (the "Effective Time").
