**DECLARATION OF ETHAN G. ORLINSKY**

ETHAN G. ORLINSKY, pursuant to 28 U.S.C. 1746, declares:

1. I am Corporate Secretary of Major League Baseball Properties, Inc. ("MLBP"), the agent for all of the MAJOR LEAGUE BASEBALL clubs, including St. Louis Cardinals, LLC (the "Registrant"), which is the owner of the ST. LOUIS CARDINALS MAJOR LEAGUE BASEBALL club (the "Club") and all of its U.S. trademarks and registrations, including, without limitation, the above-captioned registration for the FREDBIRD mark (the "Registrant's Mark"). I make this declaration to correct the erroneous recordal of an assignment (the "Assignment") filed by the now dissolved firm Morgan, Finnegan, et al. on behalf of Glaxo Group Limited at the Assignment Recordation Branch of the United States Patent and Trademark Office ("USPTO") in connection with the above-captioned registration (the "Registration"). I make this declaration based upon personal knowledge and upon consultation of business records kept in the ordinary course of business.

2. In addition to the Registration, Registrant is the owner of numerous U.S. federal registrations for trademarks used in connection with the Club's goods and services, including Registration No. 1,161,375 for the image of the Club's mascot named FREDBIRD, shown here



3. On June 26, 1985, the now dissolved firm of Morgan, Finnegan, et al. mistakenly recorded Assignment at Reel/Frame 0498/0805 of the Registration to Glaxo Group Limited ("Glaxo"), a pharmaceutical company. The clear mistake is revealed by the fact that the Assignor is listed in the USPTO Assignment records not as the owner of the Club at that time but as Allen & Hanburys Limited, another pharmaceutical company. A copy of the TSDR record for the Registration is attached as Exhibit A hereto. Moreover, the USPTO Assignment records show that Allen & Hanburys Limited assigned other registrations to Glaxo. See, e.g. the TSDR record for Registration No. 1,095,668, attached as Exhibit B hereto. It appears that a typo in the Registration number in the Assignment occurred and that the Assignment instead intended to convey the BECOTIDE mark, Registration No. 1,252,691, which had the same last three digits as the Registration. See the TSDR record for Registration 1,252,691 attached as Exhibit C hereto.


4. At no time did Registrant assign Registrant's Mark or the Registration to Glaxo. At no time did Glaxo own any marks used by the Club, including Registrant's Mark.

5. Accordingly, Registrant requests that this correction to the Assignment records be recorded in order to reflect the true chain of title of the Registration.
