**SECUREMARK DECAL CORP.** (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware (the "General Corporation Law"), does hereby certify:

**FIRST:** That the Certificate of Incorporation of the Corporation was filed with the Secretary of State on December 29, 2009.

**SECOND:** That, pursuant to the provisions of Sections 141, 228 and 242 of the General Corporation Law, the board of directors and the sole stockholder of the Corporation, by written consents filed with the Corporation's records, duly adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, such that the name of the Corporation shall be changed to "Surys Inc."
