Whereas:

- A. Assignor is the owner of the US Trademark registration no. 3086164 "UVivatec".
- B. By Agreement which came into effect on 1 May 2017, Assignor has assigned to Assignee the ownership of the Trademark under A.

Now therefore, the Parties confirm as follows:

1. For good and valuable consideration as foreseen in the Agreement Assignor has assigned to Assignee its entire right, title and interest in and to the Trademark together with the whole goodwill of the business connected with the goods and services for which the Trademark is registered. Assignee has accepted the assignment and Assignor agrees that Assignee be recorded as owner against the Trademark in the Trademark Registry.
2. Assignee has taken over all rights and obligations regarding the Trademark including all of the Assignor's right to all claims, demands, causes of action and rights of action for infringement or otherwise accrued or accruing and all rights to costs, damages, profits, penalties and all other relief in respect of such past infringement and the right to sue for and recover and retain the same for its own use and benefit.

This Agreement has been duly signed by the authorized representatives of both Parties.


