RELEASE OF TRADEMARK ASSIGNMENT

THIS RELEASE OF TRADEMARK ASSIGNMENT ("Release") is dated as of March 30, 2017 (the "Effective Date"), by BRAMBLES HOLDINGS (UK) LIMITED ("Grantee").

WHEREAS, HOOVER GROUP, INC., HOOVER MATERIALS HANDLING GROUP, INC., and TECH OIL PRODUCTS, LLC as Guarantors (each a "Grantor" and, collectively, the "Grantors"), HFG Finance Limited as Borrower, and Grantee as Lender and Collateral Agent are, among others, parties to that certain Term Loan Credit Agreement dated as of October 21, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to that certain Trademark Short Form Second Lien Security Agreement dated as of October 21, 2016 (the "Assignment"), the Grantors granted the Grantee a security interest in all of the Grantors' right, title and interest in certain trademark applications and registrations owned by the Grantors, as more particularly described in Schedule I attached hereto (collectively, the "Trademarks"); and

WHEREAS, the Borrower, the Grantors, and the Grantee, among others, agreed to amend the Credit Agreement pursuant to that certain First Amendment to Term Loan Credit Agreement and Shared Collateral Termination Release dated as of March 30, 2017 (the "Amendment") and in connection therewith the Grantors have requested that the Grantee release its security interest in the Trademarks.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to them in the Amendment.
2. The Grantee hereby releases its lien and security interest in all of the Grantors' right, title and security interest in, to and under the Trademarks.

<sup>1</sup> Current owner seems to be Thomas Conveyor Company, which Hoover Group, Inc. assigned the entire interest and goodwill on 03/03/1988; there is a security interest dated 03/01/1988 from Thomas Conveyor Company to Hoover Group, Inc.; there is also a Right of First Refusal dated 03/14/1988 recorded from Hoover Group, Inc. to Thomas Conveyor Company. (Note that the Trademark License Agreement dated July 1, 1996 between Hoover Group, Inc. and Thomas Conveyor Company gave Hoover a license to use trademarks "Liquitote," "Tuffitote," "Flexitote" and other conjugations of the word "Tote.") The above discrepancies appear to exist between the records of the U.S. Patent and Trademark Office and the schedules to previous Hoover financing documents.

However, this trademark is included in (i) an unreleased security interest granted by Hoover Group, Inc. to Nationsbank of Georgia, N.A. recorded by the U.S. Patent and Trademark Office at reel/frame 1202/0072 on 7/1/1994; and (ii) an unreleased security interest granted by Hoover Materials Handling Group, Inc. to Nationsbank of Georgia, National Association recorded by the USPTO at reel/frame 1406/0751 on 11/7/95.
