**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of May 25, 2017, is made by **ARES CAPITAL CORPORATION**, in its capacity as administrative agent (the “**Agent**”), under the Credit Agreement referred to below (terms used in this Release and not defined herein have the meaning set forth in the Credit Agreement).

**W I T N E S S E T H**

**WHEREAS**, in connection with that certain Credit Agreement, dated as of April 24, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among Feradyne Outdoors, LLC, a Delaware limited liability company, Out Rage, LLC, a Delaware limited liability company, Muzzy Outdoors, LLC, a Delaware limited liability company, FL Archery Holdings LLC, a Delaware limited liability company (collectively, the “**Borrowers**”), Holdings, the Lenders from time to time party thereto and Agent, and together with all general security agreements, trademark security agreements, patent security agreements and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the Lenders have severally agreed to make extensions of credit to the Borrowers;

**WHEREAS**, pursuant to the Credit Agreement, that certain Security Agreement, dated as of April 24, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**SA**”), and those certain agreements described on Schedule I attached hereto (collectively with the SA, the “**Security Agreements**”), the Borrowers granted among other collateral as set forth therein, continuing security interests in the intellectual property owned by Borrowers, including the intellectual property listed on Schedule I attached hereto (the “**Intellectual Property Collateral**”); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on the dates and on the reels and frames set forth on Schedule I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to the Borrowers.


The Agent agrees, at Borrowers' expense, to cooperate with Borrowers and to provide Borrowers with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
