TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made in favor of Paciolan, Inc. ("Grantor") by PNC Bank, National Association ("Bank").
