THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “*Termination and Release*”) dated as of May 24, 2017, from WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (the “*Administrative Agent*”) pursuant to a Notice and Confirmation of Grant of Security Interest in Trademarks (the “*Notice of Grant*”) dated as of December 18, 2014 between THE LAGUNITAS BREWING COMPANY, a California corporation (as “*Grantor*”), and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Notice of Grant a security interest (the “*Security Interest*”) was granted by the Grantor to the Administrative Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Notice of Grant was recorded in the Trademark Division of the United States Patent and Trademark Office on December 18, 2014 at Reel 5421, Frame 0687; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term “*Specified Trademark Collateral*”, as used herein, shall mean all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
