**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE dated as of May 25, 2017, from Citibank, N.A. as Administrative Agent (the "Agent"), to Blue Buffalo Company, Ltd., a Delaware corporation ("Borrower") and Sierra Pet Products, LLC, a Delaware limited liability company (collectively, the "Grantors") with their principal place of business at 11 River Road, Suite 103, Wilton, Connecticut 06897.

**WITNESSETH:**

WHEREAS, reference is made to the Credit Agreement dated as of August 8, 2012 among Blue Pet Products, Inc. ("Holdings"), Borrower, the lenders from time to time party thereto ("Lenders") and Administrative Agent (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Collateral Agreement, dated as of August 8, 2012, made by Holdings, Borrower, and the other grantors from time to time party thereto in favor of the Agent (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, in connection with, and as inducement to, the Lenders extending credit to Borrower subject to the terms and conditions of the Credit Agreement, a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 8, 2012, among the Agent and the Grantors (the "Security Agreement"), Grantors, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 9, 2012 at Reel 4839 and Frame 0628;

WHEREAS, in connection with the repayment or performance of the Secured Obligations, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date of the Security Agreement and thereafter acquired in the Trademarks (including, without limitation, those items listed on Schedule A hereto). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
