RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “Release”) is dated as of April 18, 2017 by Jefferies Finance LLC, in its capacity as collateral agent for the Secured Parties (together with any successors and assigns thereto in such capacity, the “Collateral Agent”), in favor of Distribution One, LLC, a Delaware limited liability company, Interactive One, Inc., a Delaware corporation, Radio One, Inc., a Delaware corporation, Reach Media, Inc., a Texas corporation, Reach One of Indiana, L.P., a Delaware limited partnership, and TV One, LLC, a Delaware limited liability company, each with its principal office at 1010 Wayne Avenue, 4th Floor, Silver Spring, Maryland 20910 (each, a “Grantor” and collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantors, together with certain other grantors thereto, and the Collateral Agent entered into that certain Security Agreement, dated as of April 17, 2015 (the “Security Agreement”), pursuant to which Grantors executed and delivered to the Collateral Agent that certain Trademark Security Agreement, dated as of April 17, 2015 (the “Trademark Security Agreement”), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 17, 2015 at Reel/Frame 5500/0064 for Interactive One, Inc. (successor in interest to Community Connect, Inc.); at Reel/Frame 5500/0077 for Interactive One, Inc. known as Interactive One, LLC; at Reel/Frame 5500/0108 for Radio One, Inc.; at Reel/Frame 5500/0121 for Radio One of Indiana, L.P.; at Reel/Frame 5500/0134 for Reach Media, Inc.; and at Reel/Frame 5500/0158 for TV One, LLC;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, the Grantors granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in the following (the “Released Collateral”): all of the Grantors’ right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademark registrations and applications set forth on Schedule 1; and


WHEREAS, the Collateral Agent desires to terminate and release the Security Interest in the Released Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent on behalf of the Secured Parties, hereby terminates, releases and forever discharges the Trademark Security Agreement and the Security Interest in the Released Collateral, and retransfers and reassigns to each Grantor any right, title or interest the Collateral Agent may have in, to or under such Grantor’s Released Collateral.


